Since 2005, FCM's Standing Committee on Increasing Women's Participation in Municipal Government has undertaken a number of initiatives, activities, and programs to encourage women who are considering running for municipal office. At time of publication, FCM's project *Diverse Voices for Change*, an initiative to increase the number of women from diverse communities actively informed by, and engaged in, local government decision-making, will contribute to FCM's mandate of achieving 30 per cent women's participation in local government by 2026 by increasing the diversity of women in leadership roles at the municipal level.

Each of the thirteen Mi'kmaw Bands in Nova Scotia operates their elections under slightly different rules – some have Custom Election Codes, others use the Indian Act, while several have opted in to the provisions of the First Nations Elections Act.
